

Air Force Installation and Mission Support Center

Overview

Air Force Installation and Mission Support Center (AFIMSC) serves as the single intermediate-level headquarters responsible for providing installation and mission support capabilities to 77 installations across the U.S. Air Force and U.S. Space Force. The AFIMSC cross-functional team provides globally integrated management, resourcing and combat support operations for Airman and family services, base communications, chaplain, civil engineering, contracting, financial management, logistics readiness, public affairs, and security forces programs.

The Air Force stood up the center to make the best use of limited resources in managing and operating its installations. Centralization of management support helps the Air Force realize better effectiveness and efficiency in providing installation and expeditionary combat support capabilities to wing commanders and mission partners. The consolidation of more than 150 capabilities at AFIMSC also helps major commands and direct reporting units focus on their primary mission areas.
