Overview

The Air Force Nuclear Weapons Center (AFNWC) is the nuclear-focused center within Air Force Materiel Command (AFMC) synchronizing all aspects of nuclear materiel management in direct support of Air Force Global Strike Command (AFGSC).

Headquartered at Kirtland Air Force Base, New Mexico, the center has 18 locations worldwide and consists of four major execution directorates: Air Delivered Capabilities; Intercontinental Ballistic Missile (ICBM) Systems; Nuclear Command, Control, and Communications (NC3) Integration; and Nuclear Technology and Interagency.
